

## REGULATIONS

Dear ride and rescue participant!

Please note that by registering for ride and rescue you accept the following conditions of participation:

### **1. Participation and Submission Clause**

The participant declares that they are physically fit to participate in this event and that they can handle realistic emergency scenarios. Each participant is responsible for the suitability and roadworthy condition of his or her bicycle and must take care of insurance cover himself. The participant is not entitled to blocked roads and routes. The provisions of the road traffic regulations therefore apply; each participant must observe the road traffic regulations at all times. If vehicular traffic occurs, the participant must give priority to the safety of all other road users over the competition objective. The participant must follow the instructions of the police, the security forces and the event manager.

### **2. Competition rules, recognition as further training (doctors, paramedics, qualified nursing staff, etc.)**

When signing up, the participant acknowledged and agreed to abide by the competition regulations, which are published separately on the homepage [www.rideandrescue.at](http://www.rideandrescue.at) (found under: competition regulations). The evaluation is carried out by an independent jury according to international guidelines for prehospital patient care. Participation is credited as: 10 hours of training according to SanG §50 for Rettungs- und Notfallsanitäter, 10 hours of further training according to GuKG §63 for qualified nursing staff, 10 DFP points for doctors (when participating only on the day of the competition), 8 DFP points for doctors (when participating in the theory part, extra day) emergency physician refresher according to § 40, ABS. 3, Ärztegesetz (only when participating in the competition and the theory part).

### **3. Disclaimer**

The organizer is not liable, regardless of the legal reason, for property damage and financial losses of any kind and their consequences, which the participant suffers during or in connection with participation in the event as a result of the behavior of the organizer, his representatives, vicarious agents or agents breach of obligations that are not main contractual obligations, limited to damage caused intentionally or through gross negligence. In the event of a breach of main contractual obligations, the organizer's liability in cases of simple negligence is limited to foreseeable, typically occurring damage. Insofar as the organizer's liability for damages is excluded or limited, the participant also releases the employees - workers and employees - representatives, vicarious agents, sponsors, as well as all other persons who have been assigned an order in connection with the implementation of the event, from personal liability for damages.

### **4. Cancellation or modification of the event**

The organizer is entitled to make changes to the execution of the event or to cancel the event in cases of force majeure or due to official orders or for safety reasons. In these cases, the organizer is not liable for damages towards the participant and no expenses of any kind (such as hotel, travel expenses, etc.) - apart from the entry fee - will be reimbursed.

### **5. Cancellation**

If the team cancels the registration, refunds of 50% will be given up to the 21st day prior to the start of the event. For administrative reasons, no refunds can be issued starting on the 21st day prior to the event.

### **6. Filming and photographing for participants**

In order not to disrupt the course of the event, image and sound recordings (photos, videos, digital recordings, audio recordings, etc.) are only permitted after consultation with the event manager.

#### **7. Declaration of consent to film and photo recordings**

The participant grants the organizer the free, irrevocable, non-exclusive right, unlimited in time and place, to use the recordings made by him during or in connection with the event. The photos as well as film and sound recordings may be published in connection with reporting or advertising in the media, for example in daily newspapers, etc. Furthermore, the photos as well as film and sound recordings may be reproduced, distributed (e.g., on [www.rideandrescue.at](http://www.rideandrescue.at) and in social media), presented, broadcasted, archived, and made available to the public.

#### **8. Privacy**

The participant expressly agrees that his personal data, namely name, address, date of birth, e-mail address, telephone number, may be processed and stored by the organizer for archiving purposes. This consent can be revoked by the participant at any time by telephone, e-mail, or letter.

#### **9. Jurisdiction**

The district court of Gänserndorf is agreed as the place of jurisdiction. Austrian law applies.

#### **10. Severability**

Should individual provisions be ineffective in whole or in part, or should there be a gap, the validity of the remaining provisions or parts of such provisions shall remain unaffected. Instead of an invalid provision, a provision that comes as close as possible to its economic purpose shall be deemed to have been agreed.
